- To be eligible for the One Account with overdraft option and the BOQ Specialist Platinum credit card ("the products"), you must be an Australian citizen or Australian permanent resident.
- You must be a full time student enrolled in your final two years of a medical or dental degree at a recognised Australian University (see Appendix 1).
- In your final year, you can apply for an overdraft limit of up to \$10 000 and in your second last year, you can apply for an overdraft limit of up to \$7 000. Credit limits are subject to BOQ Specialist credit approval.
- You can only withdraw funds from the overdraft account up to your credit limit. If you have fully used your credit limit you cannot make any further payments or withdrawals of funds, however, interest will still be calculated and added to your account balance each month. If the credit limit is not fully drawn, any interest charged to your account will reduce the amount available to you to withdraw.
- The overdraft does not have an end date it is a revolving line of credit. If you have any available balance, you can access those funds at any time. We can also demand repayment of the facility at any time.
- If you have utilised the overdraft and have a balance owing to us, you can repay
  amounts into the account at any time. However, you must start making repayments
  of the monthly interest commencing 1st July following the year you expect to
  graduate, as indicated on your application form.
- Interest is calculated each month based on the daily overdraft balance outstanding and then added to your account at the end of each month so that the interest compounds monthly. The overdraft interest rate on the account is variable.
- There is no establishment fee payable by students for the One Account with
  overdraft option. There are however, other fees such as dishonour fee, same day

- The maximum credit limit for the BOQ Specialist Platinum credit card will be \$6 000 for students. Subject to BOQ Specialist Credit Approval.
- While you are a student you will not be able to request an additional cardholder to be linked to your BOQ Specialist Platinum credit card.
- Interest is calculated on the daily balance outstanding and charged onto to your account at the end of each statement period (the last day of each calendar month). Daily interest is calculated using the daily interest rate (annual interest rate/365). The current interest rate on the credit card is available on the Key Facts Sheet attached to the application form at boospecialist.com.au/card.
- A payment on your credit card account is due by the 25th of each calendar month. You can pay the closing balance of the account, the minimum payment amount or some other amount. The credit card account is not required to be settled in full each month but we do require a minimum payment to be made on or before the 25th of each month.
- The minimum payment is the greater of \$20 and 2% of the closing account balance for the statement period.
- If you only make the minimum repayment, you will lose your interest free days on your purchases.
