

BOQ Specialist \$100 Wish Card Competition ("Competition")

Terms & Conditions

BACKGROUND

- The promoter of the Competition is BOQ Specialist, a division of Bank of Queensland Limited ABN 32 009 656 740 of Level 22, The Chifley Tower, 2 Chifley Square, Sydney NSW 2000 (Promoter).
- 2. Information on how to enter and the prizes form part of these terms and conditions. If there is any conflict between these terms and conditions and any other published material, these terms and conditions will prevail.
- 3. By entering the Competition, participants are deemed to accept these terms and conditions.

COMPETITION PERIOD

4. The Competition commences and concludes on the dates and times specified in the promotional material to which these terms and conditions are attached (**Competition Period**). Entries received by the Promoter after the Competition Period are ineligible for the prize draw.

ELIGIBILITY AND PARTICIPATION

- 5. Entry to the Competition is open to Australian residents over the age of 18, who are currently studying a medical/dental/veterinary degree at any recognized Australian university.
- 6. Directors, employees and agents (including the immediate family members of a Director, employee or agent) of the Promoter are ineligible to enter the Competition.
- 7. To enter the Competition, an Eligible Participant must, fully complete and submit the entry form via the link provided. Only complete entries will be accepted.
- 8. An Eligible Participant who submits an entry in accordance with these terms and condition will receive one (1) entry into the Competition (**Eligible Entry**). THE PRIZE

PRIZE DRAW

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for, and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition and/or: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking of the prize.
