

BOQ Specialist ADX Melbourne Competition Terms & Conditions:

BACKGROUND

- This competition (Competition) is promoted by BOQ Specialist a division of Bank of Queensland Limited ABN 32 009 656 740 AFSL and Australian Credit Licence number 244616 (the Promoter).
- 2. Information on how to enter and the prizes form part of these terms and conditions. If there is any conflict between these terms and conditions and any other published material, these terms and conditions will prevail.
- 3. By entering the Competition, participants are deemed to accept these terms and conditions.

COMPETITION PERIOD

4. The Competition opens at 10:00am AEDT on Thursday 3 October 2024 and closes at 6:00pm AEST on Saturday 5 October 2024 (**Competition Period**). Entries received by the Promoter after the Competition Period will be ineligible for the prize draw.

ELIGIBILITY PARTICIPATION

- 5. Entry is open only to Australian residents, over the age of 18, who are registered dentists in Australia and who register and attend ADX Melbourne held at the Melbourne Convention and Exihibition Centre in Melbourne, Victoria between Thursday 3 October 2024 and Saturday 5 October 2024 (Eligible Participant).
- 6. Directors, employees and agents (including the immediate family members of a Director, employee or agent) of the Promoter and dental suppliers of dental goods and services to Australian registered dentists are ineligible to enter the Competition.
- 7. To enter the Competition and be entered into the Major Prize Draw, an Eligible Participant must complete and submit one (1) entry form at the BOQ Specialist stand at ADX Melbourne (Eligible Entry). Only one (1) entry per Eligible Participant is permitted. The entry form must be completed in full and must set out the entrant's full name, email, contact number, occupation and the State or Territory in which the Eligible Participant is registered to practice as a dentist. The Eligible Participant also has the option to nominate a product or products of the Promoter listed on the entry form that they are interested in learning about but it is not mandatory. The Eligible Participant is not required to purchase or apply for the product or products of the Promoter. Only entries via this method will be accepted.
- 8. Eligible Participants are responsible for ensuring the information provided is accurate. Incomplete, indecipherable or rejected entries will be deemed invalid.
- Eligible Participants can also participate in the daily Target Tennis Challenge and be entered into a Bonus Daily Prize Draw that will run each day during the Competition Period. An Eligible Participant is permitted a maximum of 1 entry only to compete for the Bonus Daily Prize during the Promotion Period.

The Promoter reserves the right, in its sole and absolute discretion, to verify the validity of entries and the identity of participants (including age, employment details and place of residence), to disqualify any entrant who tampers with the entry process or engages in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Competition and to reject any entry that is not in accordance with these Terms and Conditions. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

THE PRIZE

- 12. There are four (4) Prizes to be won during the Competition Period consisting of three (3) premium dinner vouchers that can be redeemed at any Hunter Street Hospitality premium venue: Rockpool Bar & Grill, Spice Temple, Saké Restaurant & Bar, The Cut Bar & Grill and Bar Patrón to the value of \$300.00 for each dinner voucher which will be awarded as the prize for the Bonus Daily Prize and one (1) Major Prize valued at \$3,400.00. The Major Prize is made up of:

- 13. The total Prize value is \$4,300 (inclusive of GST).
- 14. The Promoter is not responsible or liable for any change in the value of the Prize between the date of the publication of these Terms and Conditions and the date the Prize is claimed.
- 15. The Prize is not transferable or exchangeable and cannot be taken as cash and is not redeemable for other benefits. The Competition is not available in conjunction with any other offer.
- 16. If the Prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the Prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
- 17. The winner of the Major Prize and their nominated guest are responsible for all costs or expenses relating to the Major Prize and its acceptance and redemption not otherwise specified in these terms and conditions, including, but not limited to, spending money, meals, transport, insurance (including excesses), additional taxes, and any other ancillary costs incurred by the Winner of the Major Prize and their nominated guest.
- 18. The Winner of the Major Prize and their nominated guest are responsible for obtaining any necessary travel insurance, and documents required to travel to the relevant places (if necessary) at their own expense.

PRIZE DRAW

The Major Prize Winner will be the first valid and Eligible Entry drawn manually via random selection from the cumulative pool of all Eligible Entries received by the Promoter.

- 21. The competition for the Bonus Daily Prize is a game of skill. The Eligible Participant with the highest score at 4pm AEST each day during the Competition Period will be the winner of the Target Tennis Challenge and will be awarded one Bonus Daily Prize at the BOQS stand.

If the Major Prize is unclaimed or forfeited, the Prize will be redrawn at 12:00pm AEST on Thursday 31 October 2024 at BOQ Specialist, Level 49, 120 Collins Street, Melbourne VIC 3000.
- 23. The redrawn Major Prize Winner will be notified by telephone and email by Friday 1 November 2024 and announced on the BOQ Specialist website and BOQ Specialist LinkedIn page by Friday 8 November 2024.
- 24. To accept the Major Prize, the Major Prize Winner must respond to the notification in the manner and within the timeframe set out in the notification provided by the Promoter informing them of the fact they are the Major Prize Winner. If for any reason the Major Prize Winner does not take / redeem the Major Prize at/by the time stipulated by the Promoter or fails to respond to the Promoter as required or at all, then the Major Prize will be forfeited. No compensation will be offered if the Major Prize is not taken or is otherwise forfeited.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees").
- 30. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees and the Promoter (including its respective officers, employees and agents) is not responsible for, and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition and/or: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking of the Prize.

- cancel, terminate, modify or suspend the Competition as appropriate subject to any written directions from a regulatory authority.
- 33. The Promoter, subject to relevant laws and any written directions from a regulatory authority, reserves the right to cancel, terminate, modify or suspend the Competition for any other reason.
- 34. If the Competition is cancelled, terminated, modified or suspended for any reason or the Terms and Conditions are amended, a notice will be published on BOQ Specialist's LinkedIn page and on the Promoter's website.
- 35. Once the Prize is booked, no changes will be permitted to any booking unless authorised in writing by the Promoter, and any expenses or costs associated with changes to any other component of the Prize, including delays or cancellation and/or other incidental costs, will solely be the responsibility of the Prize Winner.
